#### Final Budget Language

20	SECTION 9133. Nonstatutory provisions; Natural Resources.
25	(2) Relocation of chief state forester and division of forestry employees.
1	(a) The department of natural resources shall relocate the headquarters for the
2	chief state forester to an existing department facility north of STH 29 no later than
3	January 1, 2018.
4	(b) The department of natural resources may allow individuals who are
5	employed by the division of forestry on the effective date of this paragraph and
6	located in the department office at 101 South Webster Street in the city of Madison
7	to relocate to existing state-owned or state-leased facilities north of STH 29
8	designated by the chief state forester.
9	(c) For the 2017-18 and 2018-19 fiscal years, for each employee who relocates
10	under paragraph (b), the department of natural resources shall authorize payment
11	of the moving expenses described under section $20.917(1)(a)$ of the statutes.
12	(d) By February 1, 2019, the department of natural resources shall submit a
13	report to the governor and the cochairpersons of the joint committee on finance on
14	the number of employees who have relocated under paragraph (b).

#### Selection Criteria for FRHQ

  - Telepresence
  - Conference and meeting rooms



#### **Forestry Mill Tax**

- Mill Tax rate set at 0%
- Replaced with GPR based on current formula
- Leg Fiscal will be conducting an audit of the Forestry Account

## Managed Forest Law Administration



- All tax law work will be consolidated into fewer positions.
- Customers and partners will benefit by improved consistency and efficiencies with tax law administration
- Will continue to ensure program requirements are satisfied and sound forestry is practiced.
- Ensure Wisconsin's forests provide a sustainable supply of wood fiber to forest industries

## **Service to Private Landowners**

- Creating a new position to develop and direct outreach campaigns and assistance to private woodland owners.
- Increasing the number of hours that our field foresters have available to assist private woodland owners.
- Increased investment will translate into greater landowner awareness and forest management.
- Will still be a resource for landowners on a wide range of forestry issues.

#### **Prescribed Fire**

Forestry Division will become the central administrator for all of the agency's prescribed burn activities.
Will help the agency use its resources more effectively
Prescribed burning will continue to be a valuable tool.



### **County Forests**

- Time Standards a high priority workload With vacancies and hurricanes, western fires we remain committed to making sure core work is scheduled to be done and meet the high quality standards we all expect
- FY 17: 48,700 hours or 107% of annual goal
- FY 18: 12, 391 hours or 27.2% of annual goal
- Beginning work on the next 4 year agreement on time standards.



### **GNA** in Wisconsin

- YTD 5,000 acres 70,000 cords equiv. sold. Estimated \$3.5 million in market value.
- End of August 12 sales with estimated 25K cord equivalent bid out. Estimated \$1.0 million value.
- GNA has helped make CNNF #1 timber producing national forest in the country.
- 7 counties have signed MOAs; five have worked on sales.
- Fiscal Audit and Assurance of Compliance was conducted by USFS. Results in November.

# Good Neighbor Authority (GNA)

- Re-allocate 3 full-time equivalents (FTE) of staff time to coordinate and manage the GNA agreement.
- Provides liaison with the CNNF on the
  - GNA agreement and administrative functions
  - establishment and

## Worker Protection Standard (WPS)

- WPS is a federal regulation to reduce the risks of illness or injury to workers and handlers resulting from exposure to pesticides
- WPS is only applicable to pesticide applications for the purpose of timber and seedling production.



## Worker Protection Standard (WPS)

- WPS applies to foresters within the DNR because we use, hire and contract the use of pesticides in the production of forest products.
- WPS also applies to DNR foresters working on county lands, county foresters, and forestry companies offering pesticide services or who have employees working in an area that is being treated or that was treated with a
   <sup>3/7/18</sup> pesticide within 30<sup>r</sup> days of the application.



## **Requirements of WPS**

- Notification of pesticide use on a state property where forestry work is occurring at the "Central Posting" location where all forestry staff with work responsibilities for that property can see the information
- Proper signage at the pesticide application site, when required



### **Requirements of WPS**

- Personal protective equipment (PPE) requirements and decontamination site requirements
- Annual training by a certified pesticide applicator, EPA approved trainer or DATCP trainer



### NEW WPS PROTOCOL

- As an employer, the Wisconsin DNR is required to ensure that our contractors are following these federal requirements.
- To do that we will include language in our contracts where pesticide applications are part of the contract or for work contracted in an area where a pesticide was used in the last 30 days after the Restricted Entry Interval (REI) expired (ex. Tree planting crew)
